


European Union Structural Funds





This brochure aims to give an overview of the European Union Structural Funds that will grant support to Estonia in the coming years.

In order to channel aid from the European Union Structural Funds to various fields important for the development of Estonia, "The Estonian National Development Plan for the Implementation of the Structural Funds – Single Programming Document 2004–2006" (SPD) has been elaborated in Estonia. This document will serve as the basis for all activities related to EU Structural Funds in Estonia in 2004–2006.

This reference book is intended to give answers to questions about the essence, aims, supported activities and size of assistance of the Structural Funds. In addition, guidelines for finding application requirements, submission of applications and projects financed under different funds are provided. The brochure gives only general information and further references; therefore it does not contain specific conditions for participation in tenders or the opening dates for project tenders.

European Union Structural Funds

As a member state of the European Union (EU), Estonia will have the opportunity to take part in the regional policy of the Community and to receive financial assistance from the EU budget. In short, the EU regional policy aims to ensure rapid, socially and regionally balanced and sustainable economic development. Another aim is to reduce social and economic disparities between various regions of the Community.

The EU distributes its structural assistance among three Objectives. An Objective may contain various member states or regions that have similar economic indicators or similar developmental needs in various fields. In Estonia, structural assistance can be used because Estonia is a region covered by Objective 1. This Objective assists the poorest regions of the EU where the GDP per capita is less than 75% of the Community average. Assistance is given to regions in 11 member states.

There are four Structural Funds that support the EU structural policy through Objective:

• European Social Fund (ESF), supporting promotion of skills of employees and jobseekers and promotion of employment;

• European Regional Development Fund (ERDF), supporting economic development through promotion of business environment, modernisation of infrastructure and creation of new jobs;

• European Agricultural Guidance and Guarantee Fund (EAGGF), supporting reorganisation of agriculture and rural life;

• Financial Instrument for Fisheries Guidance (FIFG), supporting balanced use of natural resources and development of competitive fisheries industry.

These four Structural Funds are implemented in Estonia on the basis of the Estonian National Development Plan (NDP). In this document, structural assistance and development aims are broken down by four priorities:

Priority 1: Human Resource Development

Priority 2: Competitiveness of Enterprises

Priority 3: Agriculture, Fisheries and Rural Development

Priority 4: Infrastructure and Local Development

Priorities are divided into measures, each aiming to support specific activities and reaching specific objectives. Please refer to additional information on the priorities and measures of the Estonian SPD at the EU Structural Funds homepage www.struktuurifondid.ee. This page also includes contact data for Implementing Agencies of measures that can be approached with additional questions about the conditions and deadlines established for submission of projects. Moreover, project applications need to be submitted to the Implementing Agency of the respective measure.

The Structural Funds homepage shows details for Implementing Agencies that are responsible for reaching the objectives set for individual measures and elaborate application conditions for the measures.

When applying for assistance from the Structural Funds, applicants may get assistance also from County Development Centres that provide counselling for project elaboration and answer queries about Structural Funds.

European Regional Development Fund (ERDF)

European Regional Development Fund is a Structural Fund that was established in 1975 with the general goal of supporting the development of economic activities and infrastructure in the European Union. The Fund mainly assists regions lagging behind with investments in production, infrastructure and development of small and medium-sized enterprises. Under this document, the ERDF supports the following activities:

• Channelling investments into production to increase or safeguard the number of jobs (investments, subsidies to partially cover loan interests, loans to small enterprises);

• Building and modernisation of infrastructure (transport, telecommunications, energy);

- · Local initiative and small and medium-sized enterprises;
- Counselling services, feasibility studies, management;
- · Innovation and technology transfer;

Improving access to capital markets (loan guarantees, raising equity capital);

• Support to capital;

• Research and technology development related to the development of labour market and human resources;

- Project preparation, monitoring and assessment;
- Investments into education and health systems;

• Investments into environmental protection (water and waste management).

The support for Estonia from the ERDF budget totals 226 million euros in 2004–2006.

In order to describe projects that may be granted assistance from the ERDF, some examples of potentially successful projects are given here.



These examples should clarify the conditions for implementation of projects and the assistance granting system. However, it should be noted that the principles used in these examples do not apply for all SPD measures. Each measure has its own application rules and specific conditions. These conditions can be found on the homepages of Implementing Agencies for each respective measure. The list of homepages is given in a table at the end of this reference book.

Example on sub-measure "Export Plan Programme" of SPD measure 2.1 "Business Development"

A company manufacturing timber houses or furniture that wishes to export its products abroad or participate in fairs organised abroad, may apply for assistance in the framework of the Export Plan Programme. Enterprises registered in Estonia wishing to enter foreign markets and having the export turnover of the latest financial year of fewer than 150,000,000 Estonian kroons may be recipients of the assistance.

Under the programme, an application for assistance may be prepared for buying counselling services for drawing up an export plan in a sum not exceeding 75,000 kroons and for implementing that plan in a sum not exceeding 1,000,000 kroons.

Under the implementation of an export plan, assistance may be applied for to buy a counselling service supporting the implementation of the plan, visits to and participation in fairs abroad, feasibility studies of foreign markets, organisation of contact events in target markets and marketing events for the target markets, and compiling and publishing of promotional materials. In both cases the maximum amount of assistance will be 50% of total eligible project costs, i.e. costs that are eligible according to the requirements of the EU Structural Funds.

More detailed conditions are given in the homepage of Enterprise Estonia www.eas.ee/ekspordiplaan. Queries can also be made to County Development Centres all over Estonia. Consultants working at these centres will give advice as to how to further develop project ideas and how to draw up a project. Export plan development applications are proceeded successively within 35 working days and the projects for the plan's implementation by project rounds within 42 working days starting from the first date of each quarter.

An export plan development assistance will be paid to the recipient after the export plan is completed. An export plan implementation assistance will be paid to the recipient once a quarter after the recipient of assistance has implemented project activities and paid the invoices related to the project.

Example on SPD measure 2.2 "Assistance to "Business Infrastructure Development"

Under the programme assistance is given to enterprises operating outside Tallinn to help them eliminate bottlenecks that hinder effective economic operation, including building and renovation of energy, water and sewerage networks. Support is also given to build the connecting roads necessary for the economic activities of enterprises, and to reconstruction of loading grounds, parking lots and storage yards bordering such connecting roads.

Applications may be submitted by local governments (if enterprises are beneficiaries of projects), commercial enterprises registered in Estonia with a state or local government participation therein not exceeding 25%, and self-employed persons. Projects targeted on export and based on modern technology are preferred. Investments foreseen in the project need to promote entrepreneurship in areas outside Tallinn.

The minimum assistance amount is 100,000 kroons, the maximum up to five million kroons per project. Applications will be submitted for application rounds that take place six times a year and will be reviewed within 42 working days. The assistance will be paid to the recipient after the recipient has implemented project activities and paid the invoices related to the project.

European Social Fund (ESF)

The European Social Fund was established in 1960 and has developed into an important tool in the EU labour market policy. The ESF aims to improve job opportunities for both employees and the unemployed, focus on retraining of employees and create new jobs.



ESF programmes implementing local development plans (in the case of Estonia the National Development Plan) last for seven years. Fields of activity in employment and social inclusion are designed to comply with annual employment action plans that the member states implement as part of the European Union employment strategy. The Ministry of Social Affairs, which is the agency responsible for employment in Estonia, uses the finances of the ESF to implement the national employment action plans.

Projects implemented in Estonia with co-financing from the ESF must comply with the overall ESF objectives:

- Fighting unemployment;
- Integrating young people in the labour market;
- Promoting equal opportunities in the labour market (including gender mainstreaming);

• Promoting the skills, abilities and professional qualification of employees through vocational education;

- · Creating new jobs;
- Developing the education and further education system;

 Conducting all-Estonian pilot schemes related to employment and creation of jobs;

Linking human resources to research and technology transfer;

• Teacher and mentor training, creating connections between training centres and enterprises, promoting higher and secondary vocational education related to employment.

The ESF will support Estonia with 76 million euros in 2004–2006.

In order to better describe projects that may receive assistance from ESF, some examples from real life are given below. These examples should clarify the process of project content development, conditions for implementation of projects and the assistance granting system. However, it should be noted that the principles used in these examples do not apply for all SPD measures. Each measure has its own application rules and conditions. These conditions can be found on the homepages of Implementing Agencies for each respective measure. The list of homepages is given in a table at the end of this reference book.

Example on the implementation of SPD measure 1.1 "Educational system supporting the flexibility and employability of the labour force and providing opportunities of lifelong learning for all"

A vocational education institution (hereinafter: VEI) wishes to develop a new curriculum for information technology and system technicians training. As this is currently a very topical field in Estonia, the VEI decides, after studying the SPD, to apply for the ESF in order to receive co-financing for the project. The best guidance for project drafting is to refer to the guidelines on the homepage of Innove, Foundation for Life-long Learning Development, that includes the necessary application documentation.

When implementing the new curriculum as a project of measure 1.1, a national co-financing must be 25% of the total sum, while ESF will provide a co-financing of 75%. As the VEI is an agency in the field of administration of the Ministry of Education and Research, it is allowed to make an allocation from its budget to provide the Estonian match funding of the project. The minimum assistance amount to be given to a project is 225,000 kroons and the maximum project cost can be 300,000 kroons.



The quality of the project will also be enhanced by partnership with other organisations, e.g. partnership between the VEI and the private sector to organise practical training for students in enterprises. Also, new study materials to be created will add value to the project.

Applications may be submitted to Innove at least twice a year during open application rounds that will last for 30-60 days. Information about application rounds is available on Innove homepage and through Innove information list.

A decision to finance the project will be made no later then within 60 working days after the deadline established for submission of applications, and the project assistance will be paid by the principle of reimbursement. Payment claims may be submitted to Innove, as the project implementer wishes, up to twice per month, and they will be reimbursed within 14 working days. If the VEI has no resources to cover the costs of the project itself and it cannot take a loan due to restrictions established by legislation, an advance payment or a partial advance payment may be applied for when submitting the project application.

Example on SPD measure 1.3. "Inclusive Labour Market"



A non-governmental organisation decides to carry out a project to help disabled people to enter the labour market. After the idea is elaborated and possible activities are established, partners need to be found. Having a partner in the project will add value to the project. When filling out an application "The Applicant's Handbook" should be consulted in order to find advice and recommendations on the supported activities and costs. To certify a partner's participation in the project the partner has to attach its certifying letter to the application form.

It has to be taken into account while drawing up the initial budget for the project that up to 80% of the costs may be funded by the ESF and the Estonian match funding must be at least 20%. It means that at least 20% of the funding of the project must be covered by the state budget. The extent of the ESF subsidy also depends on whether the person applying for support is an enterprise or some other legal person. More detailed information about the subsidies and the public co-financing to be provided by Estonia is given in the "The Applicant's Handbook". For example, if the eligible costs spent on counselling, training and employment of disabled people through creation of jobs or adjustment of workplaces or practical training sites amounts to 300,000 kroons, then the co-financing to be provided by the ESF will be 80% of the eligible costs, i.e. 240,000 kroons.

Applications can be submitted to the Labour Market Board (LMB) during specified application rounds, except for applications of projects meant to help people who have received a notice of dismissal from work due to redundancy. Such applications are not tied with the application rounds and will be received at any time. A decision to satisfy or not satisfy an application will be made within 50 working days of the deadline for submission of applications.

The subsidy will be paid on the basis of actual expenses made by project implementers, i.e. twice a month documents certifying the incurred expenses can be presented to the LMB.

European Agricultural Guidance and Guarantee Fund (EAGGF)

European Agricultural Guidance and Guarantee Fund was established in 1962 with the aim of promoting structural changes in agriculture. Projects implemented in Estonia and co-funded by the EAGGF have to comply with the objectives of the EAGGF:

• Structural strengthening and reorganisation of agriculture and forestry;

- Elimination of unfavourable production conditions;
- · Promoting diversification of economic activities in rural areas;

 Improvement of animal keeping conditions and hygiene, marketing and processing, and working conditions for farmers;

 Achieving a sufficient living standard in farms, accompanied by improvement of structure of buildings; investments to cut production costs and raise the quality of products;



- Investment in rural infrastructure;
- Development of environmental and landscape protection.

During 2004–2006, the support from the EAGGF to Estonia will amount to 56 million euros.

In Estonia, the Agricultural Registers and Information Board (ARIB) distributes the agricultural and rural life subsidies from the EAGGF. In fact, ARIB has the responsibility to both organise the granting of state support and grant the EU agricultural and rural life assistance.

In order to better describe projects that may receive assistance from the EAGGF, some project examples are given below. The two examples should clarify the conditions for implementation of projects and the assistance granting system. However, it should be noted that the principles used in these examples do not apply for all SPD measures. Each measure has its own application rules and conditions. These conditions can be found on the homepages of Implementing Agencies for each respective measure. The list of homepages is given in a table at the end of this reference book.

Example on SPD measure 3.3 "Diversification of Economic Activities in Rural Areas"

An entrepreneur operating a shop in a village or small town who plans to build a new shop or renovate the old building and to buy new equipment for it, has the opportunity to apply for co-funding for the SPD measure 3.3 – Diversification of Economic Activities in Rural



Areas To receive the assistance, the entrepreneur must be registered in the Register of Economic Activities and must have operated for at least 12 months.

Applicants may draw up an application and a business plan themselves or use a consultant. Up to 50% of the service fees paid for elaboration of a shop's renovation or building design and business plan may be reimbursed from the Structural Funds.

The maximum amount of support is 50% of the investment costs (without VAT) but no more than 1.56 million kroons. Applications are received at the regional offices of ARIB; it will take up to 50 working days to process them. An entrepreneur may start with the investments (renovation of shop) after submitting the application. The support money will be paid within three months after the documents certifying the investments are submitted to ARIB.

Example on SPD measure 3.5 "Renovation and Development of Villages"

A NGO (e.g. a village society) planning to build a new or renovate the existing village centre in its village or small town may apply for the Renovation and Development of Villages assistance. The NGO need not be registered in the area where it intends to build or renovate a centre.

Also, enterprises operating in a territory of a village or small town where a centre is built or renovated, may apply for a funding. In order to be eligible for support, an NGO or an enterprise must have operated for at least six months.



A NGO must be registered in the Register of Non-profit Organisations and Foundations and an enterprise must be registered in the Register of Economic Activities of Enterprises.

A NGO may get a reimbursement of up to 90% of its eligible investments and an enterprise may get a reimbursement of up to 65% of its eligible investments. In the case of enterprises, the amount of assistance will depend on their size and location. The upper limit of assistance per project is 936,000 kroons per year and 2.34 million kroons total per three years. Applicants may fill out the application and draw up a short overview of a development plan themselves or use the help of a consultant. The short overview of a development plan must be based on the development plan of the village or small town.

Applications will be received at ARIB regional offices and will be reviewed within up to 75 working days. Entrepreneurs and NGOs may begin investments (building or renovating a village centre) after receiving a confirmation letter from ARIB. The assistance will be paid within three months after the documents certifying investments are submitted to ARIB. It means that, in the first place, investments to the village centre have to be self-financed.



Financial Instrument for Fisheries Guidance – FIFG

Financial Instrument for Fisheries Guidance was established in 1993 with the aim of strengthening structural measures in fishing. As the problems and bottlenecks of fisheries sector differ across countries, various measures and projects are applied to level off regional disparities. The SPD describes the projects co-funded by the FIFG and their objectives which must comply with the general goals of the FIFG:

- Coordination of activities in the field of fishing;
- Fleet modernisation;
- · Reconstruction, modernisation and renewal of the fishing fleet;
- Protection of certain maritime areas;
- Modernisation of facilities at fishing ports;
- · Production and marketing of fish products;
- Improvement of fish processing conditions;
- Promotion of products;
- · Identifying new fishing locations; finding new markets;
- Development of fishing ports;
- Development of fish breeding; marketing of fish products.

In 2004–2006, the FIFG assistance to Estonia will amount to 12 million euros.

The European Union Structural Fund FIFG distributes fishing subsidies in Estonia through the Agricultural Registers and Information Board (ARIB).

Example on SPD measure 3.11.2. "Investment support to Aquaculture"

An enterprise operating in aquaculture or wishing to start fish breeding and build a fish breeding pond and to buy the necessary equipment for it, may apply for an investment support to aquaculture (SPD measure 3.11.2). To be eligible to support, an enterprise must have operated for at least 12 months.

The maximum amount of EU co-funding is 50% of the investment costs (not including VAT) but no more than 2.1 million kroons. If an investment is meant to decrease environmental load, the co-funding may amount up to 60% of the investment costs (without VAT). Also, up to 60% of the service fees paid for drawing up a business plan may be reimbursed.

Applications will be received at ARIB regional offices and will be reviewed no later than within 50 working days. An enterprise may start investing (building a pond) after submitting the application. The assistance will be paid within three months after the documents certifying investments are submitted to ARIB.

Detailed assistance granting conditions are described in "The Applicant's Handbook" on ARIB homepage www.pria.ee. Information can also be obtained at ARIB regional offices. Applicants may draw up the application themselves or use a consultant.

Example on SPD measure 3.10 "Modernisation and Renewal of Fishing Fleet"

An enterprise having a fishing-boat or fisherman's licence that catches fish at sea and plans to buy a new fishing boat or to equip the existing fishing-boat with new geographical positioning devices, may apply for



Modernisation and Renewal of Fishing Fleet support (SPD measure 3.10). To receive a modernisation support, the fishing-boat owned or used by the applicant must have been registered in the National Register of Fishing-Boats for at least five years preceding submission of the application. In the case of a renewal support, a fishing boat must be registered in the register after it is built or purchased.

The amount of assistance granted is up to 50% of the investment costs (without VAT) if the applicant is a small or middle-sized enterprise. If the applicant is a large enterprise, the support may not exceed 40%. The maximum allowed amount of assistance will depend on the total capacity of the fishing-boat. Moreover, up to 50% of the service fee paid for a fishing boat construction or reconstruction design and the application may be reimbursed.

Application forms and additional information are also available at the regional offices. Applicants may draw up the application themselves or use a consultant.

Applications will be received at ARIB regional offices and will be reviewed no later than within 50 working days. An enterprise may start investing (purchasing geographical positioning devices) after submitting the application. The assistance will be paid within three months after the documents certifying investments are submitted to ARIB.





Financial Instrument for Fisheries Guidance (FIFG)
